## **Annual Report**

## The Annual Report of 2021—22 for Tenants in Sandwell

An Annual Report is a regulatory requirement under the Tenant Involvement and Empowerment Standard so all boards / Councils should be signing off to the HCA that they have done one.

The annual report was introduced to allow tenants to hold landlords to account for their performance and the information provided should equip tenants to challenge as well as being a useful document to share information and celebrate success.

#### **HCA** standard

Registered providers shall support their tenants to develop and implement opportunities for involvement and empowerment, including by:

- (a) supporting their tenants to exercise their Right to Manage or otherwise exercise housing management functions, where appropriate
- (b) supporting the formation and activities of tenant panels or equivalent groups and responding in a constructive and timely manner to them
- (c) the provision of timely and relevant performance information to support effective scrutiny by tenants of their landlord's performance in a form which registered providers seek to agree with their tenants. Such provision must include the publication of an annual report which should include information on repair and maintenance budgets.

## Digi—Comm

## Update on our Digi—Comm project

SCIPS Digi-Comm project has gone from strength to strength.

In January we secured additional funding from SMBC to support community centres develop their digital offer. We provide training for staff and volunteers and support them to deliver a Click and Chat course. With the additional funding from SMBC we can work with individual centres to improve their connectivity ensuring they have a strong reliable broadband connection. We have recently completed this work with 2 centres, Jubilee in Tipton, and at Wednesbury 2000, and have a programme to roll this out to a limited number of centres throughout the year. This is currently a pilot and if successful we will look to push it out in future years.

The current funding from Big Lottery finishes in May 2023. Both SCIPS and our partners St Albans Community Association are committed to continue to develop and deliver digital support to our communities beyond the current funding commitment. We have already held a planning day to explore how the project could develop and will be applying for bids to enable us to continue this valuable work.






